Recombinant *Serratia marcescens* endonuclease, liquid

Recombinant *Serratia marcescens* endonuclease produced by microbial fermentation with a *Bacillus* species. The production strain used in the manufacturing of the product is a Genetically Modified Organism (GMO) of safety level S1.

NuCLEANase, food grade is supplied as brownish liquid formulated in potassium phosphate buffer pH 8.0 and 50 % (v/v) glycerol. Color can vary from batch to batch. Color intensity is not an indication of enzyme activity or quality.

The enzyme preparation is manufactured without the use of antibiotics and without raw materials from animal origin.

Storage Conditions and Stability

NuCLEANase, food grade is to be stored at $-20\text{ °C} \pm 5\text{ °C}$. The product is stable within specification range for a period of at least 24 months from the date of product release under proper storage conditions. Shipping temperature may differ from storage temperature without affecting product quality.

Enzyme Characteristics

The enzyme catalyzes the hydrolysis of phosphodiester bonds of all forms of DNA and RNA like single-stranded, double-stranded, linear, circular or supercoiled forms into smaller oligonucleotides of mainly 2-4 base pairs.
